Meier only in private, as it could be predicted that many swindlers, charlatans and frauds would appear to boast of their alleged physical or telepathic, as well as visionary and channeling contacts with them. However, this would not be very significant and was founded on the fact that a long time of technological stagnation had occurred. But with the assistance of befriended and much higher developed peoples from the DAL Universe (sister universe to our DERN Universe), the standard of technology was tremendously raised between 1975 and 1990, and a progress reached in comparison to human beings of earth that had to be calculated with a difference of 8,000 years. Since that time, the development continued to unfold even further with the help of

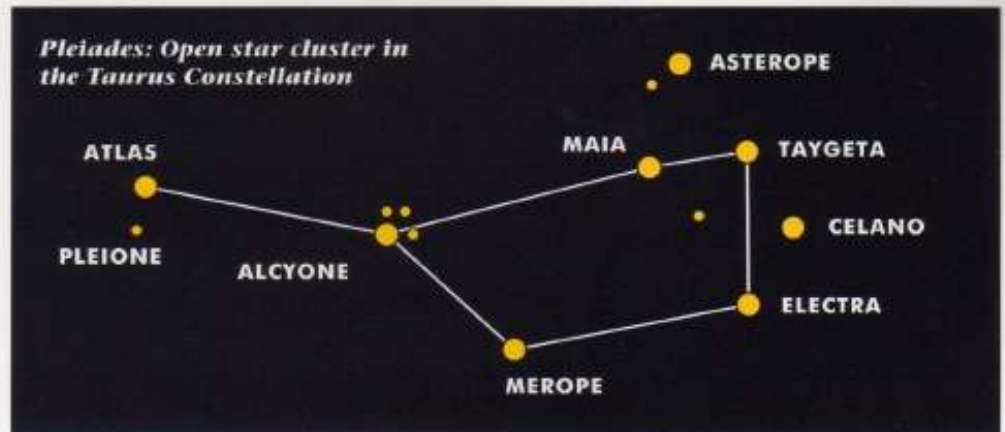
these befriended peoples, and a leap of almost 4,000 years in development was made possible again with their extensive help within a few years. Even with this immense technology, it is impossible for the extraterrestrials to reach the end of the universe, during further trillions of years, since the actual end of the universe is in a state of a perpetual new beginning in a form that the most exterior belt of the universe still expands — and thereby also all six inner belts, which comprise the universe in its entirety. Thus Semjase explained in 1975:

"We do not reach the end of the universe because such an end does not exist."

But this does not mean the most exterior belt could not be penetrated by means of immense energies through a so-called gateway to the universe in order to reach an adjacent universe, for this is precisely what the Pleiadians/Plejaren do. And they did this already in very early times, whereupon a larger group settled in the

This means there is much charlatanism, fraud and deception as far as contacts are concerned, and it is also not true that extraterrestrials are messengers of a religious kind of god, etc.

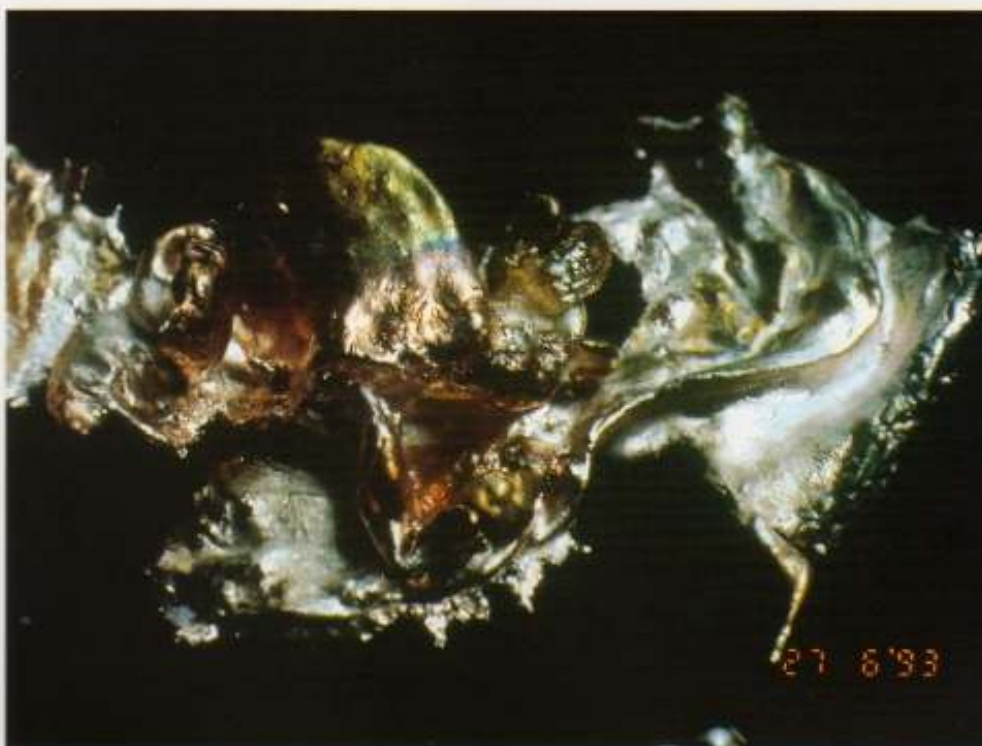
52. "As already mentioned, frauds with regard to beamships and charlatans move in the same direction.

They clearly spread the lie into the world that we, or our brothers and sisters from other parts of outer space, would come on behalf of god as angels and other such things in order to bring human beings of earth the long-awaited peace, the truth of religion and the protection and command of god.
54. This is nothing but a premeditated lie by sectarians and frauds or charlatans.
55. For we have never acted on such orders and we will never do so.
56. The Creation itself never gives orders, for it embodies the most immense and powerful entity in this universe and would never have the need of orders or religions."



"Billy" Meier's remarkable contacts and meetings with visitors from a star system approximately 500 light years away and in another space-time frame, occurred less frequently during the fall of 1976. The meetings during daytime, the possibility and the permission given by the extraterrestrials to produce movie and photographic evidence, as well as the remarkable nature of the experiences themselves, were important personal events for the Pleiadians/Plejaren and for "Billy," the ordinary and modest human being of earth. The daily work of earning his living and caring for his family, however, had priority, consequently the meetings and contacts occurred more

frequently at night, when his daily work was done, the family contented, and wife and children fast asleep in bed. This made it easier for "Billy" Meier to react to the telepathic summons from Semjase and to be on his way to the contact location always on his moped, whereby he was often obliged to drive many kilometers through secluded areas somewhere deep in a forest or in a rural and uninhabited area before reaching the place of contact to which he had been led telepathically. And the fact that these meetings always took place very far from any residential area and any possibility for human beings to turn up had its reason. Under no circumstances did the extraterrestrial visitors want to be seen by human beings of earth, much less, to come into contact with them. For example, this was repeatedly explained by the extraterrestrials during the third contact, on February 8, 1975, when Semjase said the following:

ly's" own voice and statement, so that they could be examined with a lie detector device (PSE = Psychological Stress Evaluation) in the USA. Neither "Billy's" statements nor those of the witnesses, however, could be shaken in the least.

At 7:34 p.m. on April 23, 1977, a beamship landed for the first time on the actual site of the Semjase Silver Star Center. Menara came with Semjase's ship and left landing tracks — thus the name "Menara Landing" (see Wassermannzeit #17 "Endlich wieder Spuren" and Contact Report #76).

All of them withstood the lie detector tests without detraction. "Billy's" children were also included in the witness interviews, and they were surprisingly willing to talk about and bear witness to their "friends" from heaven. They also did this without any prompting by "Billy" and without any indication that they had memorised something, or that they had been coached in the matter. The members of the investigation team repeatedly said that during the several weeks they spent in Hinterschmidrüti, everything had gone very well with the inhabitants of the Semjase Silver Star Center. The Swiss, they reported, had neither been too friendly nor too cool, but rather had simply treated the whole team humanely and on the other hand, respected their purpose for being at the Center.

"Billy" was not only the first person on earth to provide first-class films and photographs of extraterrestrial spaceships, but he was also the first to make tape recordings of the sound of the deafening whirring of a spaceship — recordings that he had made the previous summer. And regardless of the investigation team's inner struggles, they quickly realised that they were in the midst of something that inspired awe, something incredible — something that surpassed their imagination. So the team came to the consensus that "Billy" Meier's contacts had to be the first authentic and

ishing material of evidence, the team's participants concentrated on finding other unbiased scientists who were willing to perform in-depth examinations and study all the materials in detail. The utmost security and confidentiality, impartiality and expert skills were essential prerequisites for being able to guarantee a precise and exact investigation. Every individual piece of evidence had to be separately analyzed, namely for its merits and for its deficiencies; and during the process, everything had to be performed totally impartial or unprejudiced, so that a general knowledge of the Swiss events could be garnered. And there was a large amount to be tested and investigated — a very large amount.

And although various members of the investigation team returned time and again to Switzerland and the Semjase Silver Star Center in Hinterschmidrüti, 8495 Schmidrüti, as new contacts continued to occur repeatedly, and the history of contacts and the material of evidence continued to unfold, the study, as well as the investigations and analysis of the unbelievable evidence and information, were still given top priority. In further work, computer and laser examinations of photographs were carried out, and due to the more than incredible nature of "Billy" Meier's photographs, an exhaustive series of photogrammetric tests had been designed and utilized by specialists and advisors to the investigation team. The experts were specialists in the areas of optical technology, movie special effects, computer analysis and laser-scanner technology, etc. The goal of this entire work was to provide the most detailed analysis possible of "Billy's" films and photographs, as well as of the metal samples, etc. These analyzes were to be much more thorough and more critical than any of the UFO photos that had ever been examined previously. For these analyzes, other additional and advanced procedures and technologies were applied which had been used in the highly

advanced USA space travel technology, as well as in its space travel medicine and nuclear medicine.

Wendelle C. Stevens explained during investigations:

"The photos which number in the hundreds, together with the many landing tracks, the burned soil and bushes, the extraterrestrial metal and crystal samples, the 8mm movie recordings and the tape recordings of the spaceships in flight as well as the more than 3,000 pages of notes (A4 format) about 'Billy' Meier's phenomenal encounters with extraterrestrials, and the documented reports of experiences and observations of more than twelve witnesses are sufficient evidence for the Swiss contact events which could awaken a sleeping giant in us, ...the 'giant' would be the notion that other human life exists that is higher developed, and more knowledgeable than we ourselves are — and what kind of changes could a communication with them bring in our future? At no point in our history has such a mountain of solid evidence come to light."

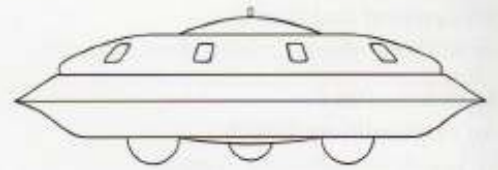
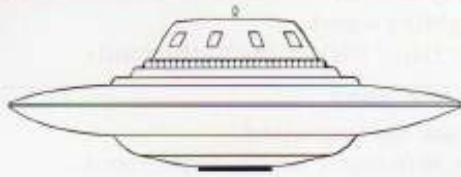

Finally, the decades-long disinformation campaign related to UFOs came to a close in Switzerland, although this did not occur until 1994. At that time, one was prepared to release Air Force documents (Division of Swiss Air Force and Air Defense) pertaining to UFO phenomena. With respect to that, it was stressed

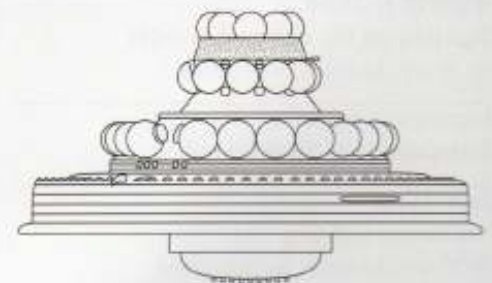
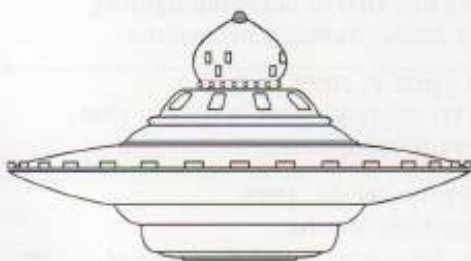
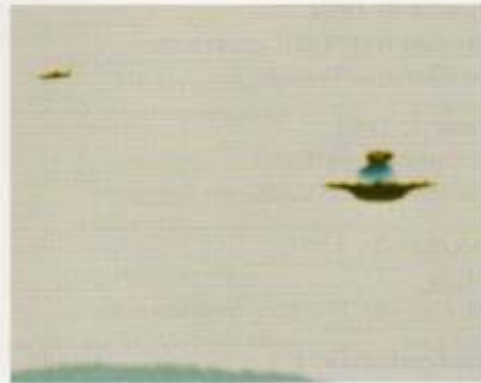
Types of Ships

The larger beamships have a diameter of seven meters and are capable of traveling through outer space. The small beamships (reconnaissance ships) measure 3.5 meters in diameter and are

capable only of interplanetary flights.

The metal of the beamships is comprised of an alloy, extracted (converted) from pure lead, which according to precise data, results without the addition of

any other metals. It is called a copper-nickel-silver alloy. For special types of beamships, the aforementioned alloy is supposed to be enriched with gold (see SEMJASE Reports).
