## **APOLLO 11 CONSPIRACY THEORIES**




Figure 1 - Apollo 11. NASA archive<sup>5</sup>

Because of my love for astronomy, I usually go out at night to look at the stars. Any astronomy enthusiast like me knows that seeing the stars in a bright environment is impossible. Our pupils need at least 4 minutes in the dark to dilate and be able to detect the faint light of the stars. If I am gathering with some friends at night and want to go to the patio to look at the stars, I see nothing in the sky when I come out. There are no stars. But after a while, and if the patio is dark, I can start to see them. But if the deck is luminous, I won't be able to see them because my pupils will remain closed due to the excess of light. Well, the same thing happens with cameras. They have a diaphragm, which, like a pupil, contracts so as not to receive excess light and overexpose the photos. And since the Moon's surface is bright, as the Sun fully illuminates the lunar soil, the camera's diaphragm is closed. It prevents the detection of the stars' dim light.

Suppose the astronauts land in a dark area on the Moon because the Sun does not illuminate it. In that case, we will ing it has also shifted. Now we see Armstrong standing on solid ground, not inside crater A. I have not drawn crater DCb in the film studio map because it does not exist.




Figure 49 - Map of the artificial terrain created in the recording studio.

In conclusion, the photos of Apollo 11 do not match what is seen on the Moon today. The location of the Lunar Module has shifted around 4 to 6 meters.
